



# THE LIFTING OF LEGISLATIVE IMMUNITIES AT THE PARLIAMENT OF TURKEY AN ASSESMENT REPORT

## Peoples' Democratic Party (HDP) 13 June 2016



#### Overview

On 20 May 2016, the Grand National Assembly of Turkey (GNAT) voted to strip over a quarter of the country's MPs of their immunity. This became possible with the joint efforts of an anti-Kurdish nationalist alliance formed between the ruling AKP and the Nationalist Movement Party (MHP). The Republican People Party's (CHP) leadership also supported the so-called "Immunity Bill" while at the same time declaring it to be anti-Constitutional. This was declared to be a statement that CHP was not siding with the People's Democratic Party (HDP), which has been targeted by government interventions and nationalist violence orchestrated by the President of the Republic since June 2015 elections.



The Immunity Bill of 20 May allows the prosecution of 139 MPs with a total of 798 dossiers voted at the Parliament at once. This involves a diverse profile of lawmakers from all four parliamentary groups. However, for anyone who reads the debates on the Bill, led by President Erdoğan, it is clear that it openly and specifically targets HDP. The bill paved the way for the prosecution of the 55 of 59 HDP MPs for their statements and actions on behalf of their constituencies. This corresponds to the 93 % of HDP's parliamentary representation.

HDP represents Kurdish political opposition, Alevite and Christian groups and other marginalized ethno-religious communities, labor and women's organizations, sexual

minorities, and ecological and environmentalist groups who have come together around the values of human rights, pluralist democracy, peace, justice, and equality.

HDP has been very active on the parliamentary floor challenging the governing AKP on the siege of Kurdish towns, endemic police violence against peaceful demonstrators, growing gender-based violence and cases of abuse of children in closed institutions. Since the June 2015 elections, HDP deputies have documented gross human rights violations against Kurdish civilians, including local leaders and municipal officials who have been killed, tortured and/or threatened by the police and the military in the sieged towns. They have challenged AKP deputies in parliamentary commissions on proposals suggesting to legalize child marriage, and have strongly opposed AKP bills aiming at establishing the infrastructure of a totalitarian police state legitimated by religion.

Mr Erdoğan and his party were relentless in declaring that the one-time lifting of the immunities that concerned the files recorded until the moment of the voting was a measure against the HDP. This politically motivated blanket lifting of immunities should be regarded as an administrative coup to exclude the Kurds and other marginalized peoples represented by HDP from the parliament of Turkey. However, as both AKP and CHP were warned by many political scientists in the run up to this voting, this was also a coup against the parliament - as part of an attempt by Mr Erdoğan to subdue all branches of the government; the legislative, the executive, and the judiciary.

This coup is also a firm step to replace Turkey's already weak parliamentary democracy with a "Turkish-type presidential system" in which the legislative, executive and judiciary powers are monopolized by the President himself, as Mr Erdoğan has openly declared.

In this critical context, we invite all persons and institutions embracing universal democratic values to meticulously observe the political and legal process in Turkey and stand in solidarity with our struggle against this totalitarian attack on the HDP and the political future of our country.

#### **Political Context**

The Turkish constitution adopted under the military junta in 1982 recognizes a limited form of parliamentary immunity. In recent history, the mechanisms limiting parliamentary immunity in issues which are unrelated to freedom of expression and political representation did not work well, for instance in facilitating prosecution of corruption and other crimes related to abuse of power. The governing AKP has had many files of this kind.

Significantly, while the promise of narrowing immunities to fight political corruption has been a key agenda in many political parties' electoral platforms since 1980s, parliamentary immunities were lifted only twice; both when nationalist alliances were formed to exclude Kurdish political representation in Turkey's Parliament.

In 1994, parliamentary immunity of Democracy Party's (DEP) Kurdish MPs was lifted and they were sent to prison under the pretext of "fighting terror." In 2009, the Democratic Society Party (DTP) was closed down, again after a campaign by the ruling AKP, which included the then Prime Minister Mr Erdoğan's targeting of DTP MPs as "supporters of terrorism." The party's co-chairs, Mr Ahmet Turk and Ms Aysel Tuğluk, were stripped of their parliamentary

seats and the co-chairs and many party executives were banned from party politics for five years.

In both instances, it was a sheer denial on the part of the establishment and its parties of a political forum for the Kurdish issue and massive human rights violations taking place around it. In both cases, excluding Kurds from the parliament aggravated the long-standing Kurdish conflict, costing tens of thousands of human lives over decades. With the DEP leadership in prison throughout the 1990s, the Turkish government had no partner for dialogue, and it was extremely risky to report grave human rights violations committed in the context of "military operations" against Kurdish populations, including displacement of two to three million Kurds.

The closure of DTP in 2009 was one of the landmarks of another episode of heightened militaristic violence that seized the provinces of the Kurdish conflict over the following three years.

The lifting of parliamentary immunities on 20 May 2015 for a third time is inherently connected to an escalated politics of violence the Erdoğan regime adopted to manage the Kurdish conflict.

In the brief period from 2013 and 2015, the AKP pursued an agenda of "democratic resolution" of the Kurdish question. During this process, many state sanctioned taboos that had long-hindered democratic debate on the issue - starting from the very words of "Kurds," "Kurdistan" or "autonomy"- were officially un-tabooed by Mr Erdoğan and his government. Encountering such "facts" in the country's historical past, Mr Erdoğan then declared, was essential for building a shared future in peace and democracy.

HDP supported and took an active role in the Resolution Process, as the mediator between the state and government bodies on the one hand, and representatives of the Kurdish armed opposition, Mr. Abdullah Öcalan, and PKK executives in Qandil-Iraq, on the other. HDP, following the practice of its predecessor Peace and Democracy Party (BDP), assumed this role upon the formal request of the AKP government and state institutions.

Mr Erdoğan abruptly ended the Resolution Process in Spring 2015 for a new Turkish nationalist alliance. This dramatic shift was calculated to prevent the spillover effects inside Turkey of the Syrian Kurdish opposition's political gains against ISIS, and to mobilize the anti-Kurdish card for manipulating the nationalist wing of the domestic opposition to not oppose his wish to become a President with executive powers, evoking the 'Ottoman legacy' of rule.

In April 2016, Mr Erdoğan declared, "there is no such thing as the Kurdish problem," and "whoever [says that there is a Kurdish question] is committing separatism." In the wake of June 2015 elections, he declared a "no compromise" policy of war, relying on the Sri Lanka model according to the AKP opinion leaders.

HDP also received its share, when the Erdoğan regime reverted to the time-honored state tradition of denial and repression of Kurds with heretofore-unseen degree of violence. Standing as it does as the only concerted opposition to Mr Erdoğan's policy of war in the country's Kurdish region and his will to a "Turkish style presidency," HDP was rebranded in this context as a "terrorist party."

Throughout the election campaign of June 7, Mr Erdoğan accused HDP of terrorism, even when ISIS attacked HDP and its supporters. When the HDP smashed the anti-democratic 10%

election threshold, gaining 80 seats in the Parliament and ending the AKP majority rule, the AKP leadership declared this to be an international conspiracy. They stated that HDP made a big mistake and would pay for it.

The immunity debate was introduced into the country's political agenda right after June 7 elections by Mr Erdoğan himself and in direct reference to HDP. The debate was resuscitated after November 1 snap elections, when the Erdoğan regime, once again, failed to prevent HDP from entering the Parliament -- despite the election threshold, lynching and murder of our members, mass arrest and imprisonment of thousands of our party executives, members and local activists, hundreds of physical attacks on our offices, and constant criminalization and scapegoating in the run-up to the elections.

At stake for the Erdoğan regime in this zealous attempt to purge HDP of the Parliament has been to kill two birds with one stone: to complete the *de facto* regression of parliamentary democracy in Turkey by formal transition to a presidential system; and to maintain the policy of war in the Kurdish region - which is intimately connected with this totalitarian recess - with absolute impunity and lack of accountability.


#### The Legislation Process

The actual parliamentary move to lift immunities gained momentum in January 2016, after Mr Erdoğan had "advised" the Parliament and the judiciary on 2 January that " [HDP MPs] should go to prison."

According to the Ministry of Justice records, by 15 December 2015, there were a total of 330 immunity dossiers pending vote at the Plenary. 319 of these dossiers were transferred from previous legislative terms, and 182 were related to HDP MPs.

In the four months that followed Mr Erdoğan's "advice," 468 new immunity dossiers were prepared, with 368 (79%) of these incriminating HDP MPs. In effect, the number of dossiers relating to HDP MPs almost tripled, rising from 182 dossiers, dated between July 2007 and Dec 2015, to 510 in May 2016. Only between 21 April and 20 May, 154 dossiers were prepared to allow HDP MPs' prosecution in a maximum number of cases.





The Immunity Bill of 20 May made a provisional exception to the constitutional immunity regulation not simply in terms of allowing blanket vote on hundreds of cases at once. It suspended the relevant constitutional procedure rather comprehensively.

The procedure of lifting parliamentary immunity is laid down in Article 83 of the Constitution. According to this, a dossier received by the Ministry of Justice is first transferred to the GNAT Joint Constitutional and Justice Commission, which investigates it on the merits and hears the incriminated MP's defense. If the Joint Commission does not find credible and sufficient evidence for the imputed charge, it returns the dossier to the Ministry of Justice. If it decides on the reverse, it sends the dossier to the GNAT Presidency, which, then, tables it at the Plenary. Before the Plenary vote, the incriminated party gives his/her defense for a second time.

The provisional amendment of May 20 bypassed this procedure at all levels. In addition to allowing blanket voting, it obstructed the parliamentary review of dossiers prior to the voting process. It is significant to note that of the 798 dossiers voted by the Plenary, 115 had not even arrived at GNAT Joint Commission or the Plenary at the time of voting. Most significantly, throughout this legislation process, the right of the MPs to defend themselves (before the GNAT Joint Commission and the Plenary) were doubly rescinded.

HDP has good reasons to believe that the source and degree of political arbitrariness which enabled the wholesale lifting of immunities will also determine the fate of the judicial processes pending in Turkey's courts.

During the consideration of the Immunity Bill at the GNAT, Mr Erdoğan campaigned against HDP in the Black Sea region, as the "impartial" President of the Republic of Turkey under the

Constitution. He said, "my nation wants them in prison." He was accompanied by the heads of higher courts, who listened to his accusations against the HDP MPs. When criticized for compromising their neutrality, the heads of the judiciary stated that it was an honor for them to accompany the President of the Republic in his visits.

Mr Erdoğan welcomed the passing of this motion at GNAT also at a public meeting with the Supreme Court of Appeals judges, who applauded with enthusiasm his threatening remarks that the HDP MPs "would be longing for these good days." These judges, who thus declared their verdict on the HDP cases they have not seen yet, will be chairing the appeal courts.


Given the unconstitutional immunity legislation as well as widespread manipulation of criminal law and "anti-Terror" legislation as a punitive mechanism against elected Kurdish mayors, journalists, pro-peace academics, or the citizens alleged to have "insulted the President," we do not expect the courts to be fair to HDP MPs.

After all, the decision of the GNAT to lift legislative immunities has nothing to do with the law; it is a political decision that violates the Constitution and the law itself, as shown above, and as also declared by the CHP leadership, who nevertheless voted for the bill.

#### **Cases and Charges Imputed**


In the process that lies ahead, the 55 de-immunized HDP MPs will be ordered to courts on account of 645 criminal charges listed in 510 cases. The imputed charges attest that targeted in this zealous de-immunization and criminalization process is not simply the act(s) of individual MPs, but the political values and principles represented by HDP as a whole.

### Distribution of Dossiers Per Crime Types (All Parties)



The above graphic shows the distribution of 820 criminal charges listed in 761 cases on the basis of the de-immunized MPs' political party affiliation. This distribution reveals a striking discord between the types of crimes that the HDP MPs and their counterparts in other parliamentary groups will face prosecution for. Virtually all charges imputed on de-immunized AKP MPs insinuate the misuse of legislative immunity for personal material gains or for escaping common criminal liability. This statistical tendency holds true to a certain extent also for de-immunized CHP and MHP MPs. In sharp contrast, virtually all crimes that HDP MPs are charged with incriminate their political activities and statements, including criticism and protests of the militarist policies and practices and reporting on human rights violations.

For instance, out of the 25 personal and property crimes (i.e. smuggling, violating the law on motor vehicles, running unlicensed business enterprise, property destruction, bid rigging, trademark infringement, fraud, embezzlement, physical assault, insulting or defaming a person) and 30 misfeasance charges listed in dossiers, 26 indict CHP MPs, 20 indict AKP MPs, 5 indict MHP MPs, and 4 indict HDP MPs. This corresponds to 44% of all charges raised against AKP MPs, 20% of all charges raised against MHP MPs, 13% of all charged raised against CHP MPs, and only 0.006 % of all charges against HDP MPs.



Common charges imputed on HDP MPs are as follows in order of frequency: "making the propaganda of a terrorist organization," "violating the law on assembly" "praising a criminal

person or an act," "insulting the president," "insulting a public officer," "inciting people to hatred and enmity," "carrying out a criminal act on behalf of an illegal organization while not being a member of that organization," "membership to an armed organization."

This thorough politico-legal language of "terrorism" has to be assessed with regards to that virtually all of the statements or actions incriminated here were carried out within the context of explaining or advocating the HDP program at the parliamentary ground, in party meetings, press statements, or public assemblies.

These deeds fall within the scope of freedom of expression guaranteed under legislative immunity, and mostly relate to criticism of Mr Erdoğan and his government's policies.

Therefore, their "terror-ization" has to be thoroughly problematized not only in relation to the merits of individual cases, but also in the general term of a concerted effort to delegitimize and liquidate the democratic alternative that HDP represents with the help of a thoroughly politicized judiciary.

The case launched against HDP Şırnak MP Faysal Sarıyıldız on charges of "supplying arms to illegal terror organizations" is a striking case in point. This case has been variously invoked in Mr Erdoğan's vilification of HDP MPs as "those who carry arms to terrorist in their cars." The summary of proceedings for the case, prepared by the Office of Public Prosecutor in Şırnak, however, commits a serious logical error in evidencing this allegation: While it clearly states that "no weaponry, ammunitions and other materials were placed in Mr Sarıyıldız's car" on the alleged crime date, it also reasons: "in this context, it is understood that Faysal Sarıyıldız committed the crime of 'supplying arms to illegal terror organizations' that he is [hereby] charged with." That is, the prosecutor admits that Mr Sarıyıldız is charged with a crime that was not committed; nevertheless he demands Mr. Sarıyıldız's immunity be lifted. The AKP officials repeatedly attacked Faysal Sarıyıldız for staying in Şırnak during the siege and destruction of the town by the military and special police teams, and recording and reporting on gross human rights violations during the "operations." Whenever he reported evidence of gross and systematic human rights violations against civilians, the government officials attacked him for supporting "terrorism."

A similar degree of careless arbitrariness marks also one of the cases filed against HDP Hakkari MP Nihat Akdoğan, on the charge of "making the propaganda of a terrorist organization." Incriminated in this case is a parliamentary question that Mr Akdoğan tabled regarding the fate of allegedly smuggled properties of various shop owners seized during a police raid in Çukurca district on 2 December 2015. The Office of the Public Prosecutor in Hakkari, who prepared the summary of proceedings, interprets Mr Akdoğan's question posed to the Ministry of Interior as "an effort to secure the continuation of material support to the PKK/KCK terror organization by requesting smuggling to be seen as a legal activity."

We briefly present below other exemplary cases that further illustrate how the "terror-ization" of the HDP MPs in the politico-legal sphere have been inextricably linked with the ending of the Resolution Process, the on-the-ground practices of warfare in the Kurdish region, and Mr Erdoğan's growingly autocratic rule which crosscuts both processes. These examples also show how the cases against HDP MPs have been poorly argued and evidenced throughout, while

observing no standard of causation or proportionality between allegedly criminal acts and the charges raised. However, as several ECHR judgments demonstrate, such politically motivated and poorly substantiated charges often succeed before the Turkish courts, especially when they are brought against HDP members and officials.

#### Terms of 'Terrorist Propaganda': Kurds and Kurdistan

The ending of the resolution process and the resuming of traditional state policy of denial of Kurds and Kurdish political demands is reflected in the cases prepared against HDP MPs not only by the numbers but also content-wise. Since the wake of 7 June elections, certain key understandings, values and perspectives defended at HDP's official party program and electoral platforms, and regularly advocated by its MPs over the years, have been criminalized by being reclassified as pertaining to "terror" or terrorism."

For instance, HDP Co-chair Selahattin Demirtaş and deputy chair of the HDP Parliamentary group, Idris Baluken, face prosecution in two separate cases on charges of "making propaganda of a terrorist organization" by using the words "Kurds" and "Kurdistan" in public addresses they made in Bingol and Diyarbakir in 2012. No doubt, these cases prove less the matter-of-factness of Kurds and Kurdistan than the scope of free and democratic debate in today's Turkey. It is also worth noting here that the use of "Kurds" and "Kurdistan" were not criminal offences during the Resolution Process, when these words were used by Mr Erdoğan himself as a gesture of challenging and disclaiming traditional state denialism toward Kurds.

#### 'Terrorist crimes' of Mediation

The ending of the Resolution Process paved the way for the incrimination of not only public articulations of Kurdishness but also the words and actions of HDP MPs carried out as the official mediators of this process.

For instance, in a case prepared by the Office of the Public Prosecutor in Diyarbakir, HDP Cochair Selahattin Demirtaş is charged with "making propaganda of a terrorist organization" in connection with a photograph of him taken at the PKK headquarters in Qandil/Iraq during the Resolution Process and covered in nationalist Turkish press.

Given that Mr Demirtaş visited Qandil many times with the knowledge and demand of state and government organs during the Resolution Process, the retrospective incrimination of a "sign" of his having been there simply does not fit well with any standard of state or government seriousness, let alone of the law.

In another case prepared by the same Office, Mr Demirtaş and MP Sırrı Süreyya Önder are charged with "forming an illegal organization with the aim of committing crime," in connection with Mr Önder's remarks during the 2013 Newroz Day celebrations in Diyarbakir: "I brought you the greetings of Kurdish popular leader Mr Abdullah Öcalan."

It is ironic that Mr Önder had made these remarks when reading aloud to a crowd of one million Newroz demonstrators Mr Öcalan's letter written to declare the Resolution Process as

the harbinger of "the ending of the era of armed struggle and the start of a new era of democracy."

The reading of the letter was part of the plan agreed with the Government of Mr Erdoğan.

#### Criminalization of HDP Program

The Erdoğan regime's transition from a politics of resolution to one of denial and conflict is reflected also in the "criminalization" of political models that inspire HDP's visions on peaceful, pluralistic and democratic coexistence Turkey, such as "democratic autonomy." This is the model that we advocate in our official party program for every socio-economic and cultural compound in Turkey for self-protecting individual and collective rights and building a sustainable future.

The term 'democratic autonomy' has been criminalized in Turkey after the victory of the PYD in the Rojava region of Syria against ISIS, and after the region was organized on the model of democratic autonomy and proposed this model for the rest of Syria.

Numerous "terror" cases have recently been prepared against our MPs for advocating "democratic autonomy" in line with our party program. For instance, in one case prepared by the Office of the Public Prosecutor in Diyarbakir, HDP Co-Chairs Selahattin Demirtaş and Figen Yüksekdağ and MPs Ertuğrul Kürkçü, Selma Irmak and Sırrı Süreyya Önder face persecution on charges of "membership in an illegal terror organization" and "inciting people to hatred and enmity" in connection with two collective public appearances: First, in an HDP election brochure that reads, "We Insist: Local Governance;" and, second, in a meeting of the Democratic Society Congress, a legally organized roof political initiative of which HDP is a member, where "Democratic Autonomy Declaration" was read in public.

HDP MP Ziya Pir has a similar case with the same charges for his remarks at a public address in Diyarbakir in November 2015: "self-governance is our right and we shall earn our right."

In yet another case incriminating the advocacy of democratic autonomy or local self-governance, Mr Demirtaş faces additional charges for advocating this model as an exercise of the HDP MPs and supporters' freedom of expression, and comparing it with the "presidential system" advocated by Mr. Erdoğan and the AKP government. At a rally in the province of Van in January 2016, Mr Demirtaş had said: "Let's get together and discuss. We say 'autonomy,' Why is yours [defense of presidency] is a right and ours is not? Let's go on live broadcast, Mr Prime Minister. You defend presidency and I shall defend autonomy." For these words, he is charged by the Office of the Public Prosecutor in Van with "attempting at destroying the unity of the state and the country," "praising a crime and a criminal," "inciting people to hatred and enmity" and "making propaganda of an illegal organization."

#### Return to war, targeting of HDP

The massive "terror-ization" of HDP MPs has to do with the general conduct of the "no compromise" warfare in Turkey's Kurdish region. The international community is growingly more aware of how this region have been turned into a war zone over the past year, hundreds

of civilians have been killed, and entire towns have been shelled to the ground through indefinite and round-the-clock curfews, which stretch from one day to a few months. These curfews were imposed, and practices under the cloud of these curfews were shielded from prosecution, under a de facto state emergency regime against Kurds, starting after the elections of 7 June 2015.

The Erdoğan regime maintains this war not only with utter disregard of basic human rights or state or governmental accountability, but also with systematic censure and denial.

It is significant to note that the towns that have been hit the longest and destroyed the most in this process, such as Cizre, Silopi, Nusaybin, Yüksekova, Silvan and Sur (Diyarbakir), are among the places that voted the highest for HDP.

Since Summer 2015, every effort of HDP MPs at disclosing this war to the wider public, monitoring grave human rights violations and carrying out advocacy on behalf of our constituencies have been violently obstructed by the Erdoğan regime, by special paramilitary forces running the war on-the-ground, as well as by numerous cases now pending trial at courts. Many of our members and officials have been killed and detained in order to suppress evidence-gathering and reporting in relation to these episodes of urban war.

Where the rule of Constitution and law has been suspended under the pretext of "fighting terror," our MPs' every effort against the war on-the-ground is incriminated by "terror" talk: making terror propaganda, aiding and abetting terror, being a member of an armed organization or forming one, inciting people to commit crime, making illegal meetings and demonstrations (violating the Law of Assembly No. 2911) or insulting the President or insulting or resisting a public officer - by simply talking about an unlawful war whose existence the regime has denied by encoding it as "anti-terror security operation." This language has proven effective in isolating the political representatives of the Kurds of Turkey and in garnering support for corrupt and violent governance in Turkey.

HDP Co-Chair Figen Yüksekdağ and MPs İdris Baluken, Feleknaz Uca, Çağlar Demirel, Altan Tan, Ertuğrul Kürkçü, Hüda Kaya, Saadet Becerikli, Mehmet Ali Aslan and Ahmet Yıldırım, who visited the town of Silvan during the thirteen-day long curfew in November 2015, are charged with "insulting the President," "resisting and obstructing an officer on duty," and "insulting a public officer." The Office of the Public Prosecutor in Diyarbakir, which prepared the case, has so far launched no investigation relating to the harassment of our MPs, and the shooting and injury of Mr Yüksekdağ on the head with a gas bomb capsule by regular and paramilitary police forces. Strikingly, the indictment enumerates as plaintiffs Mr Erdoğan, Minister of Interior Efkan Ala, and the-then Prime Minister Ahmet Davutoğlu, and Silvan District Director of Security.

Huda Kaya, HDP MP for Istanbul, has also been charged by the Office of the Public Prosecutor in Diyarbakir with "making propaganda of a terrorist organization" at a public address against the military siege in Sur district. In her incriminated address made in Jan 2016, Ms Kaya recorded that she "stands as witness to the state forces' killing of civilians, abduction of corpses, bombing of holy sites, and to all massacres denied and censured by the state and the media."

Mr Demirtaş and Mr Nimetullah Erdoğmuş, MP for Diyarbakir, are charged with "making propaganda of a terrorist organization" at a Civilian Friday Prayer mass, a civil disobedience action since 2011. Before running for the office in June 2015 elections, Mr Erdoğmuş was a senior government officer at the Directorate of Religious Affairs serving as the *mufti* (provincial jurist of Islamic law) of Diyarbakir. The indictment presents the entirety of Mr Erdoğmuş' sermon, where he comments on military operations against the residents of Sur according to the principles of Islamic jurisprudence, as "terror propaganda."

Mr Demirtaş faces trial on charges of "insulting the President" and "insulting a public officer" for having remarked during the eight-day long curfew in the town of Cizre (Şırnak province) in September 2015: "You see children are being killed in Cizre, babies are being killed, and [families] are not allowed to bury them. I just want to remind Mr Davutoğlu that he has made it into the historical records as the prime minister who did not allow children to be buried."

Over a dozen cases have been opened against our MPs alone in connection with their statements and activities regarding the second siege of Cizre between 14 December 2015 and 2 March 2016, during when more than two hundred civilians were massacred in the basements of residential buildings where they took shelter, at least thirty thousand people were displaced and residential areas were razed to the ground in entirety.

HDP MPs Alican Önlü, Ayşe Acar Başaran, Osman Baydemir and Leyla Birlik have been indicted for attending the funeral ceremony of Aziz Yural, a registered nurse at the Cizre State Hospital who was shot dead by special paramilitary forces during the siege of Cizre when he broke the curfew to attend a woman gunned down on the street by these forces. According to the Public Prosecutor in Şırnak the MPs have "made propaganda of a terrorist organization" by attending Yural's funeral. Mr. Önlü, who made a speech at the ceremony, is indicted also in a separate case on charges of "praising a crime and a criminal," "inciting people to hatred and enmity," and "insulting the President."

Several cases were filed against each and all four of the HDP MPs for Şırnak province, Faysal Sarıyıldız, Ferhat Encü, Leyla Birlik, and Aycan İrmez for their words and deeds during the long curfews in Cizre and Silopi towns. Among these are cases in which the information that they shared on twitter are incriminated with charges of "insulting the Turkish Republic, its state, its government, its military or police forces in public."

#### HDP's crimes of insulting the President

The frequency of the charge of "insulting the President" against de-immunized MPs attest to the manipulation of the immunity bill for neutralizing political opposition to Mr Erdoğan and his desire for absolute presidency. This charge is imputed 73 times in whole immunity cases, 38 times for CHP MPs, 30 times for HDP MPs, and 5 times for MHP MPs. On the one hand, these charges should be thought of next to about 2000 cases pending at Turkey's courts as testament to Erdoğan's increasingly aggressive autocratic impulse. On the other hand, the targeting of HDP MPs with this charge also attests to the links between Mr Erdoğan's rising authoritarianism in Turkey and his politics of war against the Kurdish dissent.

One of the cases filed against HDP Co-Chairs, Mr Demirtas and Ms Yüksekdağ, is especially

revealing of this symbiosis. This case relates to the well-publicized prosecution of the journalists Can Dündar ve Erdem Gül for deciphering the trucks load of weapons transferred by the Government to jihadist groups in Syria, which recently ended in their conviction on charges of "revealing secret information belonging to the state."

In a press statement, Mr Demirtaş and Ms Yüksekdağ criticized the trial of the journalist also referring to Mr Erdoğan's statement "they will pay for it," noting "the President exacts payment," for which they are asked to be tried for "insulting the president."

#### **Concluding Remarks**

What sets HDP apart from other parties represented in Turkey's political establishment is our open and programmatic commitment to achieving a peaceful, just and egalitarian resolution of Turkey's long-standing Kurdish conflict based on the recognition of Kurdish people's individual and collective rights, including the right to democratic autonomy within Turkey's territorial integrity. This commitment lies at the heart of the five to six million votes that carried us into the Turkish parliament in the successive general elections of June and November 2015.

The lifting of immunities makes an exception to the Constitution. The Constitutional Court has allowed this state of exception in a convoluted judgment in response to the petitions of the HDP MPs, signaling that it would not clash again with Mr Erdoğan. (Mr Erdoğan attacked the court and declared its judgment null and void, when the court judged the case of two journalists, Mr Dündar and Gül, in line with Turkey's obligations under the European Convention of Human Rights.)

By lifting the immunities of HDP MPs, the Erdoğan regime achieved something that they could not previously achieve through available legal and paralegal means: exclusion of the Kurdish and allied opposition, which is based on a platform radical democracy, through a concerted administrative coup.

The ECHR found again and again that the successive Turkish governments violated their international obligations every time the court judged a case of a Kurdish political party and its MPs, testifying to a systematic campaign of political exclusion.

This should be evaluated in the context of a broader campaign of regime change in Turkey, with respect to the rights of ethnic and religious minorities and of women and sexual minorities, as well as the right to freedom of expression, information and assembly, which are radically suppressed to curtail any meaningful debate and criticism of the policies and established facts of the Erdoğan regime.

This clearly raises an issue for the enforcement of Turkey's international obligations to be assessed by the Committee of Ministers of the Council of Europe as well as the Council of Europe procedures of monitoring the compliance of member states with their obligations with respect to human rights and democracy.
